ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-13720

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-13720 is held by Karl J. and Michelle Koch.
2. A search of the records of the Cedar County Register of Deeds indicates the land appurtenant to appropriation A-13720 includes the name of an owner that is different than the owner listed in Department records. This individual is Rita M. Koch.
3. Appropriation A-13720 has a priority date of August 6, 1975, and authorizes the use of water for irrigation of the 170 acres of land described below. The water may be diverted from East Bow Creek at a point of diversion located on the right bank of the stream in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 32, Township 31 North, Range 3 East of the 6th P.M. in Cedar County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 2.43 cfs from all points of diversion.

5. On March 19, 2015, Rita M. Koch filed a Relinquishment of Water Appropriation, REL-5340, in the office of the Department relinquishing the right to divert water under her portion of appropriation A-13720 for use upon the land described above.

IT IS HEREBY ORDERED appropriation A-13720 is CANCELLED.
