APPROVAL OF EXPEDITED TRANSFER EXT-5374 FOR WATER APPROPRIATION A-18732

WATER DIVISION 1-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18732 is held by Paul E. and Julie K. Folkerts.
2. Appropriation A-18732 has a priority date of December 13, 2010, and authorizes the use of water for irrigation of the 200.4 acres of land described below. The water may be diverted from the Little Blue River at a point of diversion located on the left bank of the stream in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 20, Township 4 North, Range 6 West of the 6th P.M. in Nuckolls County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 2.86 cfs.

3. On May 13, 2015, Paul E. and Julie K. Folkerts filed application EXT-5374 for a permit for an expedited transfer of the location of use and map number 19233 showing the land proposed to be irrigated under appropriation A-18732 through transfer EXT-5374.

ORDER

IT IS HEREBY ORDERED:

1. Application EXT-5374 for a permit for an expedited transfer of the location of use and map number 19233 are APPROVED.

2. Appropriation A-18732 through transfer EXT-5374 authorizes the use of water to irrigate 200.4 acres of land described below and depicted on map number 19233, which is made a part of this Order. The water may be diverted from the Big Blue River at a point of diversion located on the right bank of the stream in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 20, Township 4 North, Range 6 West of the 6th P.M. in Nuckolls County, as depicted on map number 19233. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated at a maximum rate of 2.86 cfs (1,284 gallons per minute). The total volume may not exceed 3 acre-feet per irrigated acre per year; not to exceed the least amount of water necessary for the production of crops in the exercise of good husbandry.

3. All terms and conditions of appropriation A-18732 remain in effect unless specifically changed by this Order.
4. This appropriation is subject to the provisions of the Blue River Compact and could be closed if Compact flows are not being met.
5. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
- A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
 - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may cause cancellation of part or all of this appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use an appropriation for more than five consecutive years may result in cancellation of the appropriation. This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations.

Procedures Act* §§ 84-901 et. seq. RRS and the Department's *Rules of Practice and Procedure Title 454 Admin. Code Chapter 7*. Box 94676, Lincoln, Nebraska 68509-4676) within 30 days of the date of the order and be accompanied by a filing fee of \$10.
