APPROVAL OF MAP 17670 FOR WATER APPROPRIATION A-18702

WATER DIVISION 1-C

BACKGROUND

1. On May 7, 2010, Paul E. Folkerts filed in the Department of Natural Resources (Department) application A-18702 for a Permit to Appropriate Water.
2. On May 25, 2010, Paul E. Folkerts filed map number 17670 showing land proposed to be irrigated under application A-18702.

ORDER

IT IS HEREBY ORDERED:

1. Map number 17670 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-18702 as depicted on map number 17670 which is made a part of this Order.

Township 4 North, Range 6 West of the 6 <sup>th</sup> P.M. in Nuckolls County	Acres
Section 19: NW $\frac{1}{4}$ NW $\frac{1}{4}$	31.7
NE $\frac{1}{4}$ NW $\frac{1}{4}$	30.0
SW $\frac{1}{4}$ NW $\frac{1}{4}$	39.0

3. Appropriation A-18702 authorizes the appropriator the use of water for irrigation of the 139.7 acres of land described above. The water may be diverted from the Little Blue River at a point of diversion located on the right bank of the stream in the NE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 19, Township 4 North, Range 6 West of the 6<sup>th</sup> P.M. in Nuckolls County, at a maximum rate of 2.0 cubic feet per second (cfs) (898 gallons per minute).
4. The rate that water may be diverted shall not exceed one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to three acre-feet per acre of land on which water is actually and beneficially applied.

5. The appropriator is bound by all terms and conditions of the approval of application A-18702.

ADDITIONAL INFORMATION


Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.

This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations. If you are not able to divert sufficient amounts of water, and there are junior appropriations upstream, you may call for water by contacting your local field office.
