ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-13630

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-13630 is held by the Lower Big Blue Natural Resources District.
2. Appropriation A-13630 has a priority date of June 20, 1975, and authorizes the use of 130.8 acre-feet of water from Clatonia Reservoir 4-A, storage appropriation A-12819, for irrigation of the 328.9 acres of land described below. The water may be diverted, at points of diversion located on both banks of the reservoir in the SW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> of Section 14, the NE<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub> of Section 22, and the NW<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub> of Section 23, all in Township 6 North, Range 5 East of the 6<sup>th</sup> P.M. in Gage County.


