ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-15346

WATER DIVISION 1-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that John Levendofsky is the appropriator of record of surface water appropriation A-15346.
2. On April 20, 2011, the Department received information that the land appurtenant to appropriation A-15346 had been sold and was under different ownership.
3. The Jefferson County Register of Deeds provided to the Department a Warranty Deed showing JTC Ranch, L.L.C as the owner of the land appurtenant to appropriation A-15346.
4. Appropriation A-15346 has a priority date of October 3, 1978, and authorizes the use of water for irrigation of the 96 acres of land described below. The water may be diverted from Rose Creek at points of diversion located on both banks of the stream in the NW $\frac{1}{4}$ of Section 8, Township 1 North, Range 2 East of the 6th P.M. in Jefferson County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 1.37 cfs from all points of diversion.
