ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-17593

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-17593 is held by the Larry P. and Dorothy J. Krusemark Family Funnel Trust.
2. Appropriation A-17593 has a priority date of July 2, 1997, and authorizes the use of water for irrigation of the 130.1 acres of land described below. The water may be diverted from Logan Creek at points of diversion located on the west bank of the stream in the SW $\frac{1}{4}$ of Section 9 and in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ and NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 16, both in Township 25 North, Range 6 East of the 6th P.M. in Thurston County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 1.86 cfs from all points of diversion.


