BACKGROUND

1. On May 4, 2012, Jeremy W. Heitmann, on behalf of Heitmann Brothers, L.L.C., filed in the Department of Natural Resources (Department) application A-18912 for a Permit to Appropriate Water.
2. On May 31, 2012, Jeremy W. Heitmann, on behalf of Heitmann Brothers, L.L.C., filed in the Department map number 18206 showing land proposed to be irrigated under application A-18912.
3. Construction has been completed.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18206 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18912 as depicted on map number 18206:

3. Appropriation A-18912 authorizes the appropriator the use of 24.5 acre-feet annually from Heitmann Reservoir No. 1 (storage appropriation A-18913) from a pump site located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 8, Township 1 North, Range 3 West of the 6th P.M. in Thayer County.

4. The appropriator is bound by all terms and conditions of the approval of application A-18912.
