APPROVAL OF MAP 18442 FOR WATER APPROPRIATION A-19028

WATER DIVISION 1-C

BACKGROUND

1. On February 20, 2013, Eric G. Landkamer, on behalf of Mary Landkamer, filed in the Department of Natural Resources (Department) application A-19028 for a Permit to Appropriate Water.
2. On April 3, 2013, Eric G. Landkamer filed in the Department map number 18442 showing land proposed to be irrigated under application A-19028.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18442 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19028 as depicted on map number 18442 which is made a part of this Order.

Township 3 North, Range 1 East of the
6th P.M. in Jefferson County Acres

Section 22: NW $\frac{1}{4}$ NW $\frac{1}{4}$ 22.9

3. Appropriation A-19028 has a priority date of February 20, 2013, and authorizes the appropriator the use of water for irrigation of the 22.9 acres of land described above. The water may be diverted from Big Sandy Creek at a point of diversion located on the left bank of the stream in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 22, Township 3 North, Range 1 East of the 6th P.M. in Jefferson County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.33 cfs (148 gallons per minute).
4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied.

5. The appropriator is bound by all terms and conditions of the approval of application A-19028.
