APPROVAL OF MAP 18512 FOR WATER APPROPRIATION A-19058

WATER DIVISION 1-D

BACKGROUND

1. On March 29, 2013, Harley D. Bergmeier, on behalf of the Dolores J. Hendrickson Marital Trust, filed in the Department of Natural Resources (Department) application A-19058 for a Permit to Appropriate Water.
2. On June 25, 2013, Harley D. Bergmeier, on behalf of the Dolores J. Hendrickson Marital Trust, filed in the Department map number 18512 showing land proposed to be irrigated under application A-19058.
3. Construction has been completed.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18512 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19058 as depicted on map number 18512 which is made a part of this Order.

3. Appropriation A-19058 has a priority date of March 29, 2013, and authorizes the appropriator the use of water for irrigation of the 36.8 acres of land described above. The water may be diverted from the Big Blue River at a point of diversion located on the right bank of the stream in the NE¹/₄SE¹/₄ of Section 2, Township 5 North, Range 4 East of the 6th P.M. in Saline County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.53 cfs (238 gallons per minute).

4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied.
5. The appropriator is bound by all terms and conditions of the approval of application A-19058.
