ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-8416

WATER DIVISION 2-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-8416 is held by Deborah A. Svoboda.
2. Appropriation A-8416 has a priority date of March 12, 1956, and authorizes the use of water for irrigation of the 74.2 acres of land described below. The water may be diverted from the Loup River via the headgate of the Columbus-Genoa Canal located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 6, Township 16 North, Range 4 West of the 6th P.M. in Nance County. The canal withdrawal points are located on both banks of the Canal in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 27, Township 18 North, Range 2 West of the 6th P.M. in Platte County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 83 acres irrigated at a maximum rate of 0.89 cfs.


