APPROVAL OF EXPEDITED TRANSFER EXT-2440 AND PETITION FOR A CHANGE IN THE
LOCATION OF DIVERSION RLP-2448 FOR WATER APPROPRIATION A-6016A

WATER DIVISION 1-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-6016A is held by Kerwin Elting.
2. Appropriation A-6016A has a priority date of March 2, 1954, and authorizes the use of water for irrigation of the 94.0 acres of land described below. The water may be diverted from the Little Blue River at points of diversion located on the right bank of the stream in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 11, and in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 12, both in Township 4 North, Range 7 West of the 6th P.M. in Nuckolls County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 140 acres irrigated at a maximum combined rate of 0.67 cfs from all points of diversion (301 gallons per minute).

3. On November 13, 2012, Kerwin Elting filed application EXT-2440 for a permit for an expedited transfer of the location of use for land authorized to be irrigated by appropriation A-6016A.
4. On November 27, 2012, Kerwin Elting filed map number 18356 showing the land proposed to be irrigated under appropriation A-6016A through transfer EXT-2440, and the location of the proposed pump site and the land to be irrigated under appropriation A-6016A in anticipation of the filing a petition for a permit to change the location of diversion.
5. On November 29, 2012, Kerwin Elting filed petition RLP-2448 for a permit to change the location of diversion for appropriation A-6016A from the above mentioned points to a point on the right bank of the stream in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 12, Township 4 North, Range 7 West of the 6th P.M. in Nuckolls County.
6. Construction has been completed.

ORDER

IT IS HEREBY ORDERED:

1. Application EXT-2440 for a permit for an expedited transfer of the location of use, petition RLP-2448 for a petition for a permit to change the location of diversion, and map number 18356 are APPROVED.
2. Appropriation A-6016A through petition RLP-2448 is now A-6016AR.
3. Appropriation A-6016AR through transfer EXT-2440 authorizes the use of water to irrigate 94.0 acres of land described below and depicted on map number 18356, which is made a part of this Order. The water may be diverted from the Little Blue River at a point of diversion located on the right bank of the stream in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 12, Township 4 North, Range 7 West of the 6th P.M. in Nuckolls County. Water diverted shall not exceed the ratio of one cfs for every 140 acres irrigated at a maximum rate of 0.67 cfs (301 gallons per minute). The total combined volume of all appropriations may not exceed 3 acre-feet per irrigated acre per year.

4. Appropriation A-6016AR through transfer EXT-2440 is provided additional water to land approved for irrigation by appropriation A-15549AR through transfer EXT-2441.
5. All terms and conditions of appropriation A-6016 and A-6016A remain in effect unless specifically changed by this Order.
6. This appropriation is subject to the provisions of the Blue River Compact and could be closed if Compact flows are not being met.
7. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
 - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.

ADDITIONAL INFORMATION


Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may cause cancellation of part or all of this appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use an appropriation for more than five consecutive years may result in cancellation of the appropriation.

This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations.
