ORDER GRANTING PETITION VAR-3497 FOR LEAVE TO FILE OR CONSIDER

AN APPLICATION FOR A NEW SURFACE WATER APPROPRIATION WITHIN

A MORATORIUM OR STAY AREA

WATER DIVISION 1-B

BACKGROUND

1. On July 14, 2004, the Department of Natural Resources (Department) issued an Order declaring a formal moratorium in the Republican River Basin on the issuance of all new surface water appropriations.
2. On January 31, 2013, Eva M. Hofman (Petitioner) filed petition VAR-3497 in the Department for Leave to File or Consider an Application for a New Surface Water Appropriation within a Moratorium Area (Petition). The draft application and documentation attached to the petition is for a permit to impound approximately 22 acre-feet of water from a tributary to Berger Creek in the existing Sughrone Reservoir No. 2 located in the NE<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub> of Section 13, Township 2 North, Range 28 West of the 6<sup>th</sup> P.M. in Red Willow County for the purpose of erosion control and water for livestock.
3. An aerial photograph of Section 13, Township 2 North, Range 28 West of the 6<sup>th</sup> P.M. in Red Willow County, taken in 1965, was filed with petition VAR-3497 and shows that the Sughrone Reservoir No. 2 was constructed and impounding water at that time.
4. *Nebraska Revised Statutes* § 46-714(3)(n) allows for new surface water appropriations if the Department grants leave to file an application and subsequently approves a permit for such use.
5. When filing such a petition, a project proponent must offer a clearly stated basis for such request and must offer sufficient good cause shown. *Department of Natural Resources Rules for Surface Water, Title 457 Neb. Admin. Code Chapter 23* lists six circumstances that may be put forward as justification for granting a petition to apply for a permit to impound water, in conjunction with an examination of good cause shown.

CONCLUSIONS

1. Petitioner has shown good cause in that the impoundment has been providing the benefits of erosion control and water for livestock for many years.
2. The Sughrone Reservoir No. 2 existed prior to the formal moratorium.

3. Therefore, petition VAR-3497 should be granted and the Petitioner should be allowed to file an application for a permit to impound water.


ORDER
