

RE: Application for a Permit to Transfer Ground Water to Adjoining State

To Whom It May Concern:

I would like to have applicable permits completed so that I may transfer groundwater outside of Nebraska from the City of Kimball municipal wells. The main use of the water will be for oil and gas operations.

The specific locations and time lines are required on the applications but are unknown at this time, as I do not know where the oil companies will be drilling new oil wells. I can provide this information for each sale in the future if needed. Also, I will not begin transferring any water until these permits are approved and the opportunity to transfer the water presents itself.

The City of Kimball municipal wells are located in the Ogallala formation. Water levels in these wells are approximately 200+ feet to water. No impact will be incurred by the surrounding wells because of the saturated thickness of the aquifer and the relatively small amounts of water I will be using in addition to the current municipal uses.

Alternative sources of water are limited. Irrigation allocations from the South Platte NRD restrict irrigators, and many of them no longer wish to use water for any other purpose other than irrigation. I have previously used water from municipal wells before for in-state purposes. Convenience for me is the largest contributing factor for using the Kimball municipal wells.
