APPROVAL OF MAP 18581 FOR WATER APPROPRIATION A-19050

WATER DIVISION 1-D

BACKGROUND

1. On March 22, 2013, Marjorie Cizek, Trustee, on behalf of the Cizek Living Trust, landowner, and Ron Wollenburg, operator, filed in the Department of Natural Resources (Department) application A-19050 for a Permit to Appropriate Water.
2. On July 10, 2013, Ron Wollenburg filed in the Department map number 18581 showing land proposed to be irrigated under application A-19050.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18581 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19050 as depicted on map number 18581:

Township 6 North, Range 4 East of the 6 th P.M. in Saline County	Acres
Section 35: SW $\frac{1}{4}$ SW $\frac{1}{4}$	12.9
SE $\frac{1}{4}$ SW $\frac{1}{4}$	<u>33.8</u>
TOTAL	46.7

3. Appropriation A-19050 authorizes the appropriator the use of 80 acre-feet annually from Wollenburg Pond (storage appropriations A-19046 and A-19049) from a pump site located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 35, Township 6 North, Range 4 East of the 6th P.M. in Saline County, with the permission from the appropriator of A-19046 and A-19049, Ron and Cindy Wollenburg, to divert water for irrigation from this reservoir.
4. The appropriator is bound by all terms and conditions of the approval of application A-19050.
