ORDER OF CANCELLATION IN FULL OF CONDUCT WATER PERMIT CWG-1801 (C-72)

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that conduct water permit CWG-1801 (C-72) is held by Kevin D. and Barbara D. Sasse.
2. Conduct water permit CWG-1801 (C-72) authorizes the conduction of water from groundwater well G-120976 located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 36, Township 2 North, Range 4 East of the 6th P.M. in Jefferson County.
3. The groundwater released into a tributary to Spring Creek at a point in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 36, Township 2 North, Range 4 East of the 6th P.M. in Jefferson County flows in a northerly direction into the Lottman-Carpenter Reservoir (A-18158) also in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 36, Township 2 North, Range 4 East of the 6th P.M. in Jefferson County. The water is withdrawn from Lottman-Carpenter Reservoir at a rate of 0.56 cubic foot per second (250 gallons per minute) for irrigation of the 107.4 acres described below:

4. On April 7, 2014, Kevin D. and Barbara D. Sasse filed a Relinquishment of Water Appropriation, REL-5016, in the office of the Department relinquishing the right to conduct water under permit CWG-1801 (C-72) for use upon the land described above.
