BACKGROUND

1. On August 25, 2014, Daniel R. Singleton, Trustee of the Daniel R. Singleton Living Trust dated April 1, 1997, filed in the Department of Natural Resources (Department) application A-19292 for a Permit to Appropriate Water.
2. On October 14, 2014, Daniel R. Singleton, Trustee of the Daniel R. Singleton Living Trust dated April 1, 1997, filed map number 19083 showing the land proposed to be irrigated under A-19292.

ORDER

IT IS HEREBY ORDERED:


1. Map number 19083 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19292 as depicted on map number 19083:

Appropriation A-19292 authorizes the appropriator the use of 30.0 acre-feet annually from Singleton Reservoir (storage appropriation A-19291) from a pump site located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 33, Township 2 North, Range 8 East of the 6<sup>th</sup> P.M. in Gage County, as depicted on map number 19083.
4. The appropriator is bound by all terms and conditions of the approval of application A-19292.
