FOR CONDUCT WATER PERMIT CWG-1674 (C-88)

BACKGROUND

- Records on file in the Department of Natural Resources (Department) show that conduct water permit CWG-1674 (C-88) is held by 33 Ranch LLC.
- On July 14, 2009, the Department approved application CWG-1674 (C-88) for the purpose of conducting ground water for irrigation of the 272.6 acres of land described below. Water from groundwater well G-051391 enters into the Niobrara River in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 12, Township 30 North, Range 57 West of the 6th P.M. in Sioux County to be withdrawn in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 18, Township 30 North, Range 56 West of the 6th P.M. in Sioux County.

- Petition MIP-4669 for a permit for an expedited transfer of the location of use and map number 18532 are APPROVED.



The land proposed to be irrigated with this permit is described below.
