ORDER GRANTING EXTENSION OF TIME BY PETITION EOT-4871
TO FILE MAP FOR WATER APPROPRIATION A-18998

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18998 is held by Darrell D. and Sue A. Bruns.
2. Appropriation A-18998 has a priority date of December 26, 2012, and authorizes the appropriator to store 14 acre-feet of water in Wildcat Reservoir No. 2. The water may be diverted from a tributary to Wildcat Creek at a point of diversion located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 20, Township 2 North, Range 8 East of the 6th P.M. in Gage County.
3. Pursuant to *Title 457 Neb. Admin. Code* Chapter 11, a map of reservoir was to be filed six months after the approval date of appropriation A-18998, on November 30, 2013.
4. On November 26, 2013, Darrell D. Bruns filed petition EOT-4871 in the Department requesting a one-year extension of time in which to file a map of reservoir. This petition was filed in a timely manner prior to the November 30, 2013, deadline.


ORDER

1. Petition EOT-4871 requesting a one-year extension of time is hereby GRANTED.
2. The filing deadline to file a map of reservoir under appropriation A-18998 is extended to November 30, 2014.
3. All terms and conditions of appropriation A-18998 remain in effect unless specifically changed by this Order.
