APPROVAL OF APPLICATION A-19097

WATER DIVISION 1-D

BACKGROUND

1. On June 18, 2013, Jim Peters, Trustee, on behalf of the Peters Living Trust, filed in the Department of Natural Resources (Department) application A-19097 for a Permit to Appropriate Water.
2. Construction has been completed.

ORDER

IT IS HEREBY ORDERED that application A-19097 is APPROVED subject to the following limitations and conditions:

1. The source of water is the Big Blue River.
2. The water shall be used for the purpose of irrigation.
3. The priority date is June 18, 2013.
4. Water diverted under appropriation A-19097 shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated. The maximum number of acres that may be irrigated under application A-19097 shall not exceed the number stated upon the application, and may be further limited by the Department upon approval of the required map. Total annual volume of water diverted may not exceed 3 acre-feet per acre irrigated and the least amount that can be beneficially used.
5. This appropriation is subject to the provisions of the Blue River Compact and could be closed if Compact flows are not being met.
6. The appropriator must comply with all relevant statutes. The statutes include, but are not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
 - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.

7. The appropriator must comply with the following deadlines:
- A. A map prepared according to *Title 457 Neb. Admin. Code Chapter 10* must be filed in the office of the Department by six months past the signing date of this application approval. No rights shall be deemed to have been acquired until the provisions of this paragraph have been complied with, and a failure to do so shall cause a forfeiture of the appropriation and all rights thereof.
 - B. The appropriation is not considered perfected until water has been beneficially applied for the purpose stated in this approval. The water appropriated under A-19097 must be beneficially used by September 1, 2016.
 - C. After September 1, 2016, a field investigation will be conducted to determine the acres irrigated, after which an order of cancellation will be issued for any unused portions of appropriation A-19097.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.

This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations. If in the future you are not able to divert sufficient amounts of water, and if there are junior appropriations upstream, you may call for water by contacting your local field office.
