ORDER GRANTING PETITION VAR-3528 FOR LEAVE TO FILE OR CONSIDER  
AN APPLICATION FOR A NEW SURFACE WATER APPROPRIATION WITHIN  
A MORATORIUM OR STAY AREA

WATER DIVISION 1-B

BACKGROUND

1. On July 14, 2004, the Department of Natural Resources (Department) issued an Order declaring a formal moratorium in the Republican River Basin on the issuance of all new surface water appropriations.
2. On February 6, 2013, Brent Harms, on behalf of Clara Louise Harms, (Petitioner) filed petition VAR-3528 in the Department for Leave to File or Consider an Application for a New Surface Water Appropriation within a Moratorium Area (Petition). The draft application and documentation attached to the petition is for a permit to impound approximately 75 acre-feet of water from a tributary to Turkey Creek in the existing Harms Reservoir 1163 located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 13, Township 3 North, Range 17 West of the 6<sup>th</sup> P.M. in Harlan County for the purpose of erosion control and water for livestock.
3. An aerial photograph of Section 13, Township 3 North, Range 17 West of the 6<sup>th</sup> P.M. in Harlan County, taken in 1969, was filed with petition VAR-3528 and shows that the Harms Reservoir 1163 was constructed and impounding water at that time.
4. *Nebraska Revised Statutes* § 46-714(3)(n) allows for new surface water appropriations if the Department grants leave to file an application and subsequently approves a permit for such use.
5. When filing such a petition, a project proponent must offer a clearly stated basis for such request and must offer sufficient good cause shown. *Department of Natural Resources Rules for Surface Water, Title 457 Neb. Admin. Code Chapter 23* lists six circumstances that may be put forward as justification for granting a petition to apply for a permit to impound water, in conjunction with an examination of good cause shown.

CONCLUSIONS

1. Petitioner has shown good cause in that the impoundment has been providing the benefits of erosion control and water for livestock for many years.
2. Harms Reservoir 1163 existed prior to the formal moratorium.

3. Therefore, petition VAR-3528 should be granted and the Petitioner should be allowed to file an application for a permit to impound water.

ORDER

IT IS HEREBY ORDERED:

1. Petition VAR-3528 meets the requirement of *Department of Natural Resources Rules of Surface Water, Title 457 Neb. Admin. Code Chapter 23, § 001.04*, and is GRANTED.
2. This Order granting leave to file or consider an application for a new surface water appropriation within a moratorium or stay area pursuant to petition VAR-3528 shall be in effect for one year from the date this order is signed.
3. This decision shall not bind the Director to approve any application to which it relates, or in any way be used as evidence of prejudice for the Director's future decisions concerning the specific approval requirements of such an application.
