APPROVAL OF PLAN NUMBER 19498

BACKGROUND

1. On March 22, 2016, Lynn Christensen, on behalf of Christensen Brothers Partnership, filed in the Department of Natural Resources (Department) an Application for Approval of Plans for Dams and plan P-19498.
2. The plan, P-19498, is for the Christensen Brothers Primary Finish Lagoon Dam, an existing livestock waste control dam, subject to the *Safety of Dams and Reservoirs Act*. The dam is located in the SE 1/4 of Section 32, Township 30 North, Range 13 West of the 6th P.M. in Holt County.
3. Bradley S. Woerner, P.E., of Eisenbraun & Associates, 215 Walnut Street, Yankton, South Dakota 57078, prepared the plans.
4. Christensen Brothers Partnership, 23971 County Road 10, Sleepy Eye, Minnesota 56085, owns the dam.
5. The plans were examined by a Registered Professional Engineer of the Department and were found to be consistent with current standards.
6. All of the contributing drainage area into the lagoon will be from the livestock facility and incidental drainage associated with the waste control facility.

ORDER

IT IS HEREBY ORDERED the Application for Approval of Plans for Dams and plan P-19498 are APPROVED subject to the following limitations and conditions:

The dam owner must comply with all relevant statutes. This includes, but is not limited to, the following:

- A. Notify the Department of any change in ownership or address.
- B. Receive approval prior to taking any action that changes the storage capacity of the reservoir or plan P-19498.
- C. Operate and maintain the structure in accordance with *Neb. Rev. Stat. § 46-241* and the *Safety of Dams and Reservoirs Act*, §§ 46-1601 to 46-1670.
- D. Assume liability for all damages due to leakage, overflow or structural failure of the dam.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to any orders issued by the Director of the Department of Natural Resources may result in administrative penalty, criminal prosecution, or any combination thereof.

The applicant and any person with sufficient legal interest who has been or may be substantially affected by this approval may request a contested case hearing in accordance with the *Neb. Admin. Procedures Act* §§ 84-901 et. seq. RRS and the Department's *Rules of Practice and Procedure* 454 *Neb. Admin. Code* Chapter 7. The request must be received by the Department at its Lincoln office (Nebraska State Office Building, 4th Floor, 301 Centennial Mall South, P.O. Box 94676, Lincoln, Nebraska 68509-4676) within 30 days of the date of the Approval and be accompanied by a filing fee of \$10.
