ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-6523

WATER DIVISION 2-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-6523 is held by Dan and Nancy Martensen, John and Julie Cech, and Ronald and Dawn Cech.
2. A search of the records of the Colfax County Register of Deeds indicates the land appurtenant to A-6523 is owned by CMC Land Holdings, LLC.
3. Appropriation A-6523 has a priority date of July 30, 1954, and authorizes the use of water for irrigation of the 70 acres of land described below. The water may be diverted from Shell Creek at a point of diversion located on the right bank of the stream in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 34, Township 18 North, Range 03 East of the 6th P.M. in Colfax County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 140 acres irrigated at a maximum rate of 0.5 cfs.

On June 27, 2016, Dan and Nancy Martensen, John and Julie Cech, and Ronald and Dawn Cech, on behalf of CMC Land Holdings, LLC., filed a Relinquishment of Water Appropriation, REL-5709, in the office of the Department relinquishing the right to divert water under appropriation A-6523 for use upon the land described above.

IT IS HEREBY ORDERED appropriation A-6523 is CANCELLED.
