APPROVAL OF APPLICATION A-19456 AND MAP NUMBER 19614

WATER DIVISION 1-F

BACKGROUND

1. On August 8, 2016, Michael Hayes, Managing Member of Burr Oak Lodge, LLC, filed in the Department of Natural Resources (Department) application A-19456 for a Permit to Appropriate Water.
2. On August 25, 2016, Michael Hayes filed in the Department map number 19614 showing land proposed to be irrigated under application A-19456.

ORDER

IT IS HEREBY ORDERED that application A-19456 and map number 19614 are APPROVED subject to the following limitations and conditions:

1. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19456 as depicted on map number 19614 which is made a part of this Order.

2. Appropriation A-19456 has a priority date of August 8, 2016, and authorizes the appropriator the use of 18 acre-feet of water for irrigation of the 22 acres of land described above. The water may be diverted from Burr Oak Pond at a point of diversion located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 08, Township 09 North, Range 09 East of the 6<sup>th</sup> P.M. in Otoe County, as depicted on map number 19614.
3. This appropriation will be limited to the land irrigated and the amount of water beneficially used on an annual basis. Such amount shall not exceed 18 acre-feet per annum.
4. Only the land shown on map number 19614 may be irrigated under appropriation A-19456.
5. A measuring device, approved by the Department, may be required if so ordered by the Department.
6. The appropriator must comply with all relevant statutes. The statutes include, but are not limited to, the following:
  - A. Notify the Department of any change in ownership or address.

- B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
  - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.
7. The appropriator must comply with the following deadlines:
- A. Construction of the diversion works must begin within twelve months of the signing date of this application approval. The appropriator must proceed diligently with the construction unless interrupted by some unavoidable and natural cause.
  - B. Construction of the project must be completed by two years past the signing date of this application approval.
  - C. The appropriation is not considered perfected until water has been beneficially applied for the purpose stated in this approval. The water appropriated under A-19456 must be beneficially used by September 1, 2019.
  - D. After September 1, 2019, a field investigation will be conducted to determine the acres irrigated, after which an order of cancellation will be issued for any unused portions of appropriation A-19456.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.

Box 94676, Lincoln, Nebraska 68509-4676) within 30 days of the date of the order and be accompanied by a filing fee of \$10.
