CORRECTED ORDER OF PARTIAL CANCELLATION, ASSIGNMENT OF RIGHTS AND
APPROVAL OF MAP NUMBER 19199 FOR APPROPRIATION A-768

WATER DIVISION 1-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-768 is held by Pathfinder Irrigation District (District).
2. Appropriation A-768, with a priority date of September 29, 1904, authorizes the use of water for irrigation of 110,040.0 acres. The water may be diverted from the North Platte River via the Interstate Canal headgate located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 11, Township 26 North, Range 65 West of the 6th P.M. in Wyoming. The rate that water may be diverted is one cubic foot per second (cfs) for every 70 acres irrigated, at a maximum rate of 1,572.0 cfs.
3. On February 23, 2015, the District and individual landowners filed in the Department Relinquishment of Surface Water Appropriation, in part, REL-5312 relinquishing the right to divert water for irrigation of 72.9 acres of land under A-768.
4. On February 23, 2015, the District filed in the Department Notification of Assignment of Rights, AOR-5313, to assign a portion of the water appropriated under A-768 to irrigate 72.9 acres of land.

ORDER

IT IS HEREBY ORDERED:

1. Part of appropriation A-768 in the amount of 1.04 cfs for irrigation of 72.9 acres of land described on **Attachment A** and shown on map number 19199 filed with REL-5312 is CANCELLED.
2. The Department acknowledges the Notification of Assignment of Rights, AOR-5313, filed by the District on February 23, 2015, to assign the portion of water under A-768 previously relinquished by REL-5312 to the 72.9 acres of land described on **Attachment A** and shown on map number 19199 filed with AOR-5313.
3. Attachment A and map number 19199 are made a part of this Order.
4. The land depicted on map number 19199 only represents the change of location of acres under appropriation A-768 through relinquishment REL-5312 and assignment of rights AOR-5313.

5. The right to divert 1,572.0 cfs from the North Platte River to irrigate the 110,040 acres of land under A-768 via the Interstate Canal headgate located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 11, Township 26 North, Range 65 West of the 6th P.M. in Wyoming shall remain IN FULL FORCE AND EFFECT.
6. All terms and conditions of appropriation A-768 remain in effect unless specifically changed by this Order.
7. The appropriator must comply with all relevant statutes. These relevant statutory requirements include, but are not limited to, the following:
 - A. Receiving approval prior to taking any action that changes the location of the point of diversion, a transfer of the location of the place of use, a relinquishment of a portion of the appropriation, the type of use, or the type of appropriation.
 - B. Notify the Department of Natural Resources of any reassignment of relinquished portions of an appropriation.
 - C. Comply with all relevant notices and orders of the Department.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.
