APPROVAL OF MAP 17676 FOR WATER APPROPRIATION A-18705

WATER DIVISION 1-D

BACKGROUND

1. On May 27, 2010, David Clabaugh, Manager, Lower Big Blue Natural Resources District, on behalf of landowners Mark and Janet Knobel, filed in the Department of Natural Resources (Department) application A-18705 for a Permit to Appropriate Water.
2. On June 14, 2010, Mark Knobel filed map number 17676 showing land proposed to be irrigated under application A-18705.

ORDER

IT IS HEREBY ORDERED:

1. Map number 17676 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18705 as depicted on map number 17676:

Mark and Janet Knobel are allowed to divert 131.8 acre-feet annually from Cub Creek Reservoir 17-A (storage appropriation A-12738) from a point of diversion located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 3, Township 3 North, Range 2 East of the 6<sup>th</sup> P.M. in Jefferson County, with the permission from the appropriator of A-12738, Lower Big Blue Natural Resources District, to irrigate the land described above.

4. The appropriator is bound by all terms and conditions of the approval of application A-18705.
