APPROVAL OF MAP 17677 FOR WATER APPROPRIATION A-18706

WATER DIVISION 1-D

BACKGROUND

1. On May 27, 2010, David Clabaugh, Manager, Lower Big Blue Natural Resources District, on behalf of landowners Mark and Janet Knobel, and Ralph and Martha Knobel, filed in the Department of Natural Resources (Department) application A-18706 for a Permit to Appropriate Water.
2. On June 14, 2010, Mark Knobel filed map number 17677 showing land proposed to be irrigated under application A-18706.

ORDER

IT IS HEREBY ORDERED:

1. Map number 17677 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18706 as depicted on map number 17677:

Mark, Janet, Ralph and Martha Knobel are allowed to divert 73.6 acre-feet annually from Swan Creek Reservoir 68 (storage appropriation A-17377) from a point of diversion located in the NW¹/₄SE¹/₄ of Section 22, Township 4 North, Range 2 East of the 6th P.M. in Jefferson County, with the permission from the appropriator of A-17377, Lower Big Blue Natural Resources District, to irrigate the land described above.

4. The appropriator is bound by all terms and conditions of the approval of application A-18706.
