APPROVAL OF MAP 17771 FOR WATER APPROPRIATION A-18738

WATER DIVISION 1-D

BACKGROUND

1. On January 20, 2011, Robbie Hofeling filed in the Department of Natural Resources (Department) application A-18738 for a Permit to Appropriate Water.
2. On February 1, 2011, Robbie Hofeling filed in the Department map number 17771 showing land proposed to be irrigated under application A-18738.

ORDER

IT IS HEREBY ORDERED:

1. Map number 17771 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18738 as depicted on map number 17771, which is hereby made a part of this Order:

The appropriator is allowed to divert 6.52 acre-feet annually from Hofeling Pond Number 3 (storage appropriation A-18730) by releasing water into a tributary to Wildcat Creek, passing through Hofeling Pond Number 2 (storage appropriation A-18729), and into Hofeling Pond Number 1 (storage appropriation A-18728), where it will be withdrawn at a pumpsite located on the right bank of Hofeling Pond Number 1 in the SW¹/₄NE¹/₄ of Section 33, Township 3 North, Range 8 East of the 6th P.M. in Gage County, to irrigate the land described above.
