BACKGROUND

1. On October 26, 2011, Delfred and Sara Schlake filed in the Department of Natural Resources (Department) application A-18828 for a Permit to Appropriate Water.
2. On December 13, 2011, Delfred Schlake filed in the Department map number 18015 showing land proposed to be irrigated under application A-18828.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18015 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18828 as depicted on map number 18015:



4. The appropriator is bound by all terms and conditions of the approval of application A-18828.
