BACKGROUND

1. On June 20, 2012, Michael Parde filed in the Department of Natural Resources (Department) application A-18934 for a Permit to Appropriate Water.
2. On July 25, 2012, Michael Parde filed in the Department map number 18268 showing land proposed to be irrigated under application A-18934.

ORDER

IT IS HEREBY ORDERED:


1. Map number 18268 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18934 as depicted on map number 18268:

3. Appropriation A-18934 authorizes the appropriator the use of 5.7 acre-feet annually from Parde West Irrigation Pond (storage appropriation A-18933) from a pump site located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 19, Township 1 North, Range 7 East of the 6th P.M. in Gage County.
4. The appropriator is bound by all terms and conditions of the approval of application A-18934.
