APPROVAL OF MAP 18269 FOR WATER APPROPRIATION A-18940

WATER DIVISION 1-D

BACKGROUND

1. On July 18, 2012, Claire V. Scheideler and Darrell Bruns filed in the Department of Natural Resources (Department) application A-18940 for a Permit to Appropriate Water.
2. On July 31, 2012, Darrell Bruns filed in the Department map number 18269 showing land proposed to be irrigated under application A-18940.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18269 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-18940 as depicted on map number 18269 which is made a part of this Order.

3. Appropriation A-18940 has a priority date of July 18, 2012, and authorizes the appropriator the use of water for irrigation of the 58.5 acres of land described above. The water may be diverted from Sicily Creek at points of diversion located on both banks of the stream in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 28, Township 2 North, Range 6 East of the 6th P.M. in Gage County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 0.84 cfs from all points of diversion (377 gallons per minute).

4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied.
5. The appropriator is bound by all terms and conditions of the approval of application A-18940.

Box 94676, Lincoln, Nebraska 68509-4676) within 30 days of the date of the order and be accompanied by a filing fee of \$10.
