ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-9627

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that a portion of the land located in the NE $\frac{1}{4}$ of Section 16, Township 10 North, Range 3 East of the 6th P.M. in Seward County appurtenant to surface water appropriation A-9627 is owned by the Jay Brinkmeyer Trust.
2. Records on file in the Department of Natural Resources (Department) show that a portion of the land located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 16, Township 10 North, Range 3 East of the 6th P.M. in Seward County appurtenant to surface water appropriation A-9627 is owned by Mike and Carol Pflughaupt.
3. Appropriation A-9627 has a priority date of November 16, 1956, and authorizes the use of water for irrigation of the 32.0 acres of land described below. The water may be diverted from Brinkmeyer Reservoir at points of diversion located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 16, Township 10 North, Range 3 East of the 6th P.M. in Seward County. Water diverted shall not exceed eight acre-feet per annum.
