Water will be used for the upcoming interstate Project No. NH-80-2(100) Big Springs West CN64155 contracted with NDOT. The amount of water that will be utilized is 50 acre feet in 2019 and 20 acre feet in 2020 & 2021 (resp.) This withdraw and transfer is proposed to begin in October 2019.

**Application to Transfer Ground Water
SOUTH PLATTE NATURAL RESOURCES DISTRICT**

I (We) hereby request that a ground water transfer be approved pursuant to the Districtwide Ground Water Management Area Rules and Regulations (the "Rules") of the South Platte Natural Resources District (the "District."). I (We) acknowledge that this Application is subject to any applicable rule, regulation or control and the District's Integrated Management Plan, which are in effect on the date of this Application or may be amended at a later date and that a non-refundable: 1) two hundred dollar (\$200) fee must accompany this Application, or 2) fifty dollar (\$50) fee for transfers which augment water supplies to Nebraska wetlands or streams.

Neb. Rev. Stat. § 46-739.01 and Rule 6.8 require that a current title report issued by an attorney or registered abstractor accompany this Application. The title report shall reflect (a) the owner and legal description of the land from which the ground water is to be transferred and (b) the existence of all liens evidence by the filing of a mortgage, trust deed, or other equivalent consensual security interest. The written consent of any transfer must be obtained from each lienholder before an Application may be approved. A title report and consent of lienholder is not required for a one-time transfer of 4 acres or less. **No transfer of ground water may occur until all of the conditions listed on the following page have been complied with.**

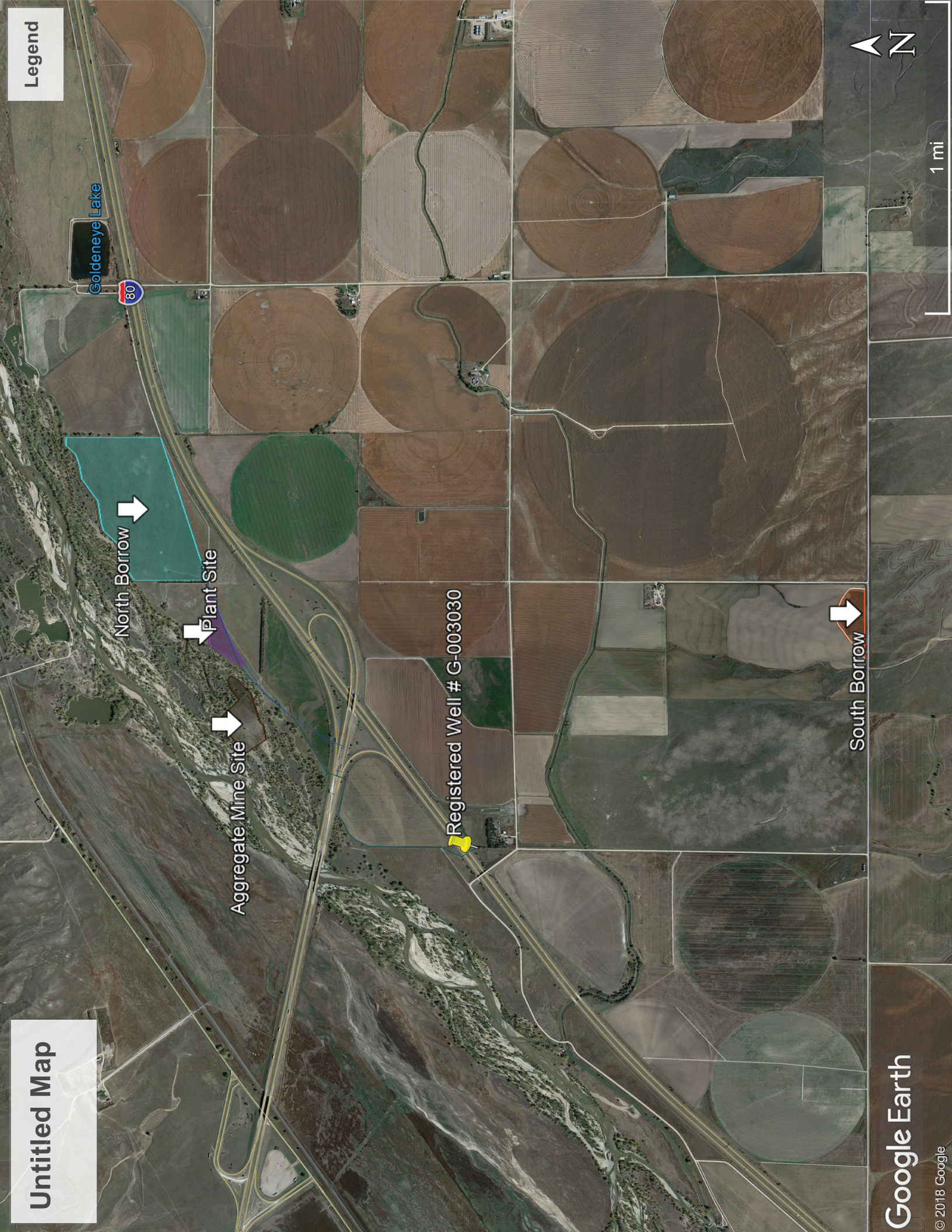
